Introduction and Overview

“Community Action Agencies have been key players in the war on poverty since their inception in the 1960’s. They are uniquely qualified to examine the needs of communities and individuals as they strive to eliminate poverty because Community Action Agencies work directly with low-income individuals and families, and so deal with the problems of poverty on a daily basis. In addition, Community Action’s unique Board structure requires that at least one-third of its members be representatives of low-income persons, one-third be elected public officials (or their designees), and the remaining members be representatives of the private sector. This tri-partite structure promotes a variety of viewpoints and expertise on both the issues and solutions affecting those in poverty. In most cases, Community Action Agencies provide a wide range of services that address a variety of poverty problems.

Why then, does poverty continue to affect so many Americans? How can Community Action Agencies develop improved and effective strategies to help people move out of poverty? Before deciding on what to do, Community Action Agencies must determine what NEEDS to be done in the communities in which they work. Before developing a plan of action (or a strategic plan), Community Action Agencies must develop a deep understanding of the current conditions, likely future trends, and issues of most concern within the community(s) they serve. In order to do so, Community Action Agencies should conduct periodic Comprehensive Community Needs Assessments of their communities.”¹

Missouri Valley Community Action Agency (MVCAA) carries out a Comprehensive Family, Community and Agency Needs Assessment every three years in the year prior to the Strategic Plan update. However, the agency sees this as an ongoing process and continually gathers reviews and assesses information collected. This assessment includes a combination of focus group input (including customers, community leaders, community partners, staff and board), written

surveys, personal interviews, data gathering and analysis, and customer satisfaction surveys. Information from other local and regional plans and assessments are also collected, reviewed and analyzed.

MVCAA's Board of Directors

The Community Service Block Grant (CSBG) Act requires that a private not-for-profit community action agency administer its CSBG Program through a tripartite board whose members fully participate in the development, planning, implementation and evaluation of the Programs and services delivered by the Agency.

One third of the tripartite board must consist of elected public officials holding office on the date of selection or their representatives.

Not fewer than one third must be persons chosen in accordance with democratic selection procedures adequate to assure that the members are representatives of low income individuals and families in the neighborhood served and if they represent a specific neighborhood, that they live in that neighborhood.

The remainder of the board must be members or official of the private groups and interests in the community (business, industry, labor, religious, law enforcement, education or other groups of interest).

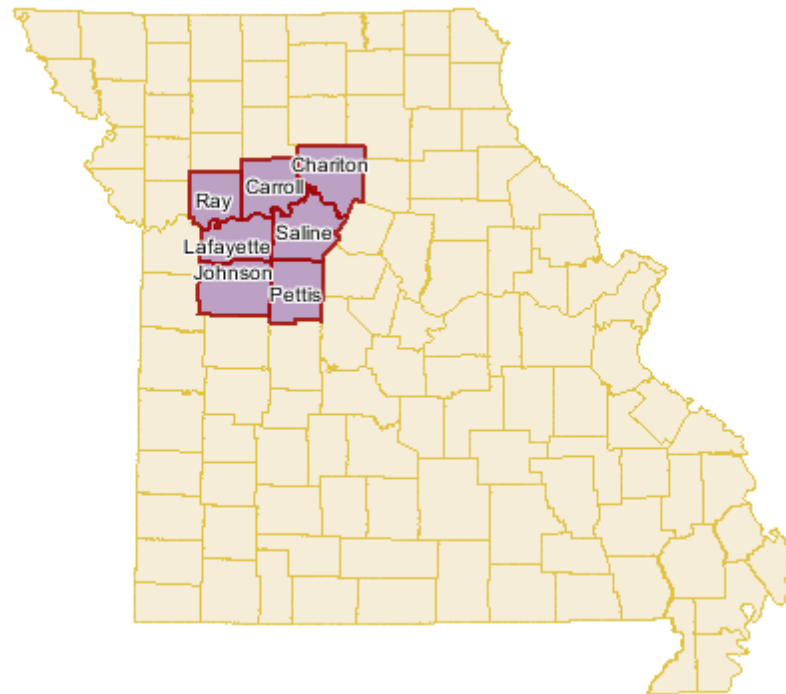

Data Collection

Data was collected by electronic and paper surveys. Surveys were distributed to staff, board members, customers and community members. A total of 536 surveys were completed. The Community Assessment Survey covered the following areas:

- Challenges To Accessing Services In My Community
- Family and Economic Security
- Health Resources Available
- Education Resources Available
- Food Resources Available
- Housing and Energy Resources Available

Focus groups were held in each of the seven (7) counties. Attending were customers of the Agency, community members, businesses, faith based organizations, school faculty, non-profit and other social service organizations. The purpose of these meetings were to discuss the needs and assets of the communities and ways that better services and Programs could be offered.

The following questions were asked of the groups:

1. How do you define poverty in your County?
2. What are the conditions and causes of poverty in your community?
3. What keeps families in poverty?
4. What should we do as a community to address poverty?
5. What resources do you have in this community to meet the need of:
 - Education
 - Nutrition
 - Housing and Energy
 - Health
 - Family and Economic Security (livable wage jobs, youth programs, affordable childcare, senior services, employment assistance)

Of these categories what are the biggest and most concerning gaps in the community?

6. What can MVCAA do to support the community to reach the goal of eliminating poverty in your County?

Staff Satisfaction Survey

Staff Satisfaction Surveys were completed by 70 staff members with the following results:

1. **69 answered** - 88.41% Look forward to coming to work
2. **70 answered** - 92.86% Have a positive and optimistic attitude
3. **68 answered** - 77.94% Feel valued by their department
4. **70 answered** - 75.71% Feel encouraged to suggest improvements in work methods
5. **69 answered** - 81.16% Feel encouraged to learn from mistakes and not reprimanded for them
6. **68 answered** - 85.29% Feel encouraged to use full range of skills
7. **70 answered** - 82.86% Feel they have input into training received
8. **70 answered** - 75.71% Feel meetings they attend are productive and well led

10. **68 answered** - 26.47% Feel that rewards and recognition are given fairly
11. **70 answered** - 88.57% See themselves working at the Agency in one year
12. **70 answered** - 62.86% Have referred someone to the Agency for employment
13. **69 answered** - 79.71% Feel that working for the Agency is more than just a job
14. **70 answered** - 54.29% Feel department Directors and Managers are highly visible
15. **69 answered** - 86.96% Feel learning is a high priority in the Agency
16. **70 answered** - 85.71% Feel that priority is placed on doing quality work
17. **68 answered** - 70.59% Feel Agency information is shared with them
18. **70 answered** - 88.57% Feel department information is shared with them
19. **70 answered** - 62.86% Feel departments work with each other to best serve clients

20. **70 answered** - 48.57% Feel there is a trust between employees and management

21. **70 answered** - 60% Feel there is frequent two-way communication between employees and management

22. **69 answered** - 85.51% Feel their health and safety are important to the Agency

23. **68 answered** - 48.53% Feel the Agency takes prompt action on their suggestions and provides them with feedback on action taken

24. **67 answered** - 65.67% Feel the Agency strives to reduce or eliminate barriers for their success

25. **69 answered** - 91.30% Feel the Agency is committed to continuous improvement

26. **67 answered** - 61.19% Feel the Agency is responsive to their needs and concerns

27. **69 answered** – 57.97% Feel the Agency is willing to take responsibility for its mistakes

Customer Satisfaction Surveys

Head Start Parent Evaluations

Head Start Parent Evaluations were completed by 121 Head Start families with the following results:

1. **121 answered** - 86.55% are satisfied with the current 4-hour/day, 4-day/week, 9-month/year Head Start school year; 38.14% family needs would be better met with a 12 month Head Start Program; 70.83% needs would be better met with a 6-hour per day, 5 day/per week Head Start Program; 12.61% needs would be better met with a full working day with no transportation
2. **121 answered** – I am satisfied with the Head Start services my family receives from:
 - 96.69% Classroom staff
 - 86.67% Transportation
 - 88.43% Family Development Specialists
 - 94.17% Head Start Program overall

11. **108 answered** – 83.33% agree that Head Start centers are friendly and inviting for fathers
12. **102 answered** - 68.63% agree that Head Start provided information on disabilities
13. **101 answered** – When help was requested for child’s disability, the services was:
- 53.47% Delivered in a timely manner
 - 54.46% useful and successful
 - 56.44% supportive of family values
14. **118 answered** – 33.05% agree that their child(ren) attend care before or after Head Start

- 28.57% agreed that the turnover had a positive effect

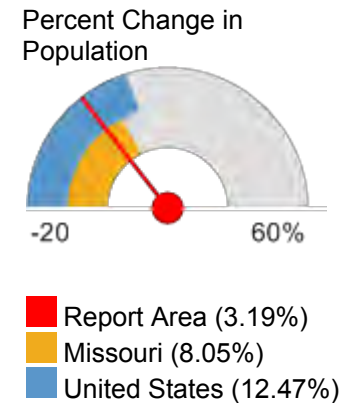

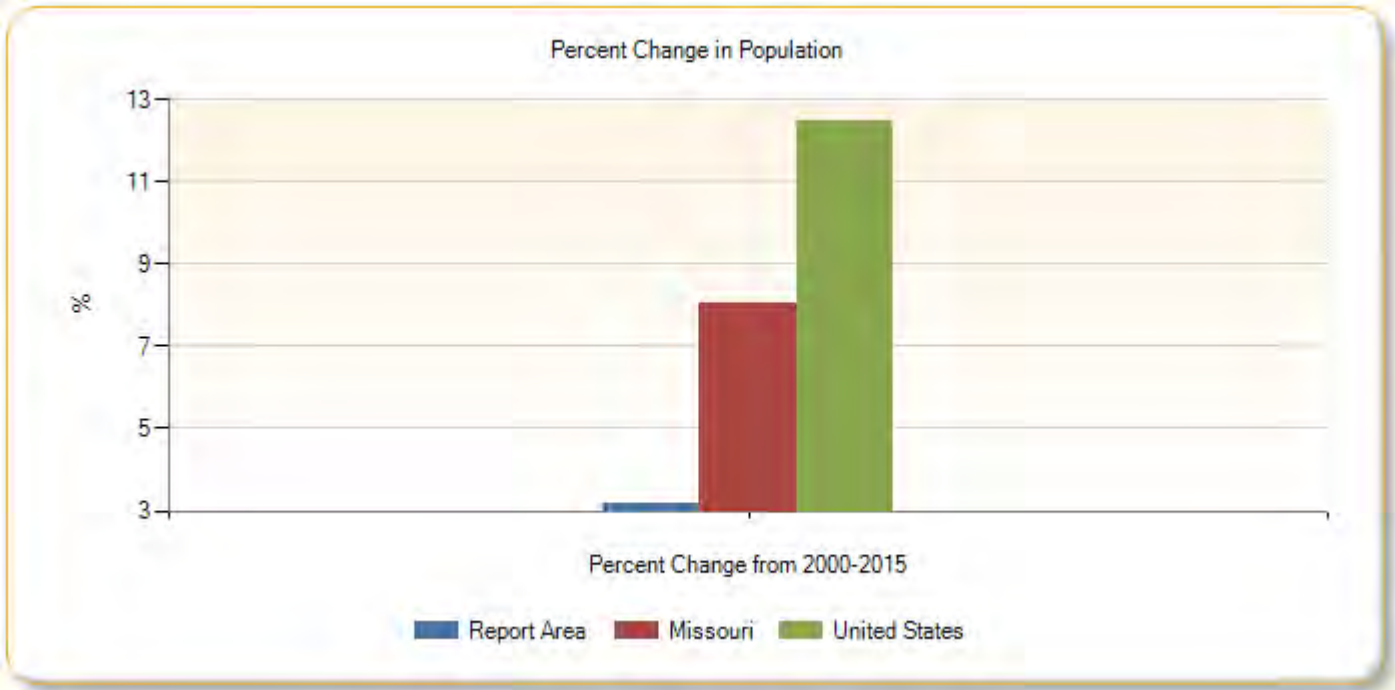
Population Change

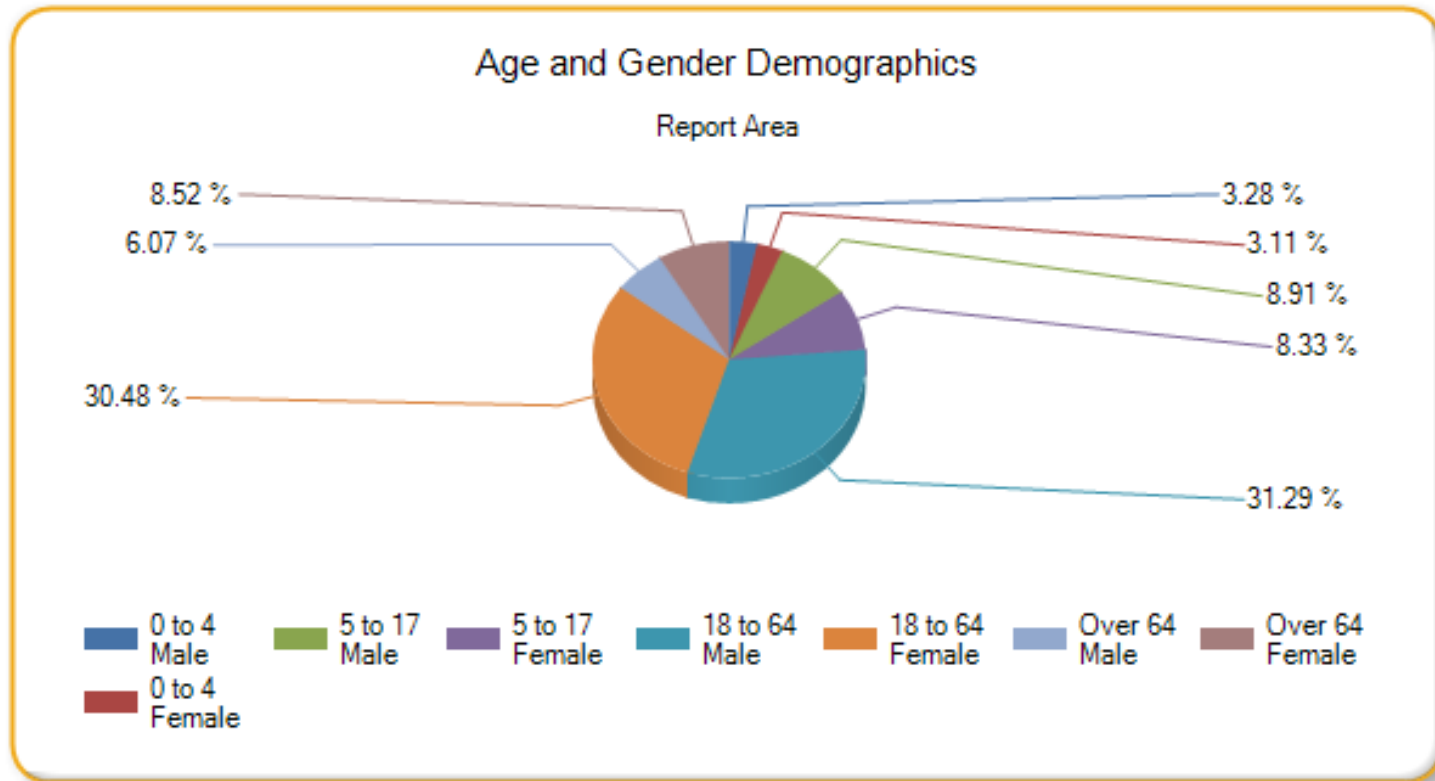


Age and Gender Demographics

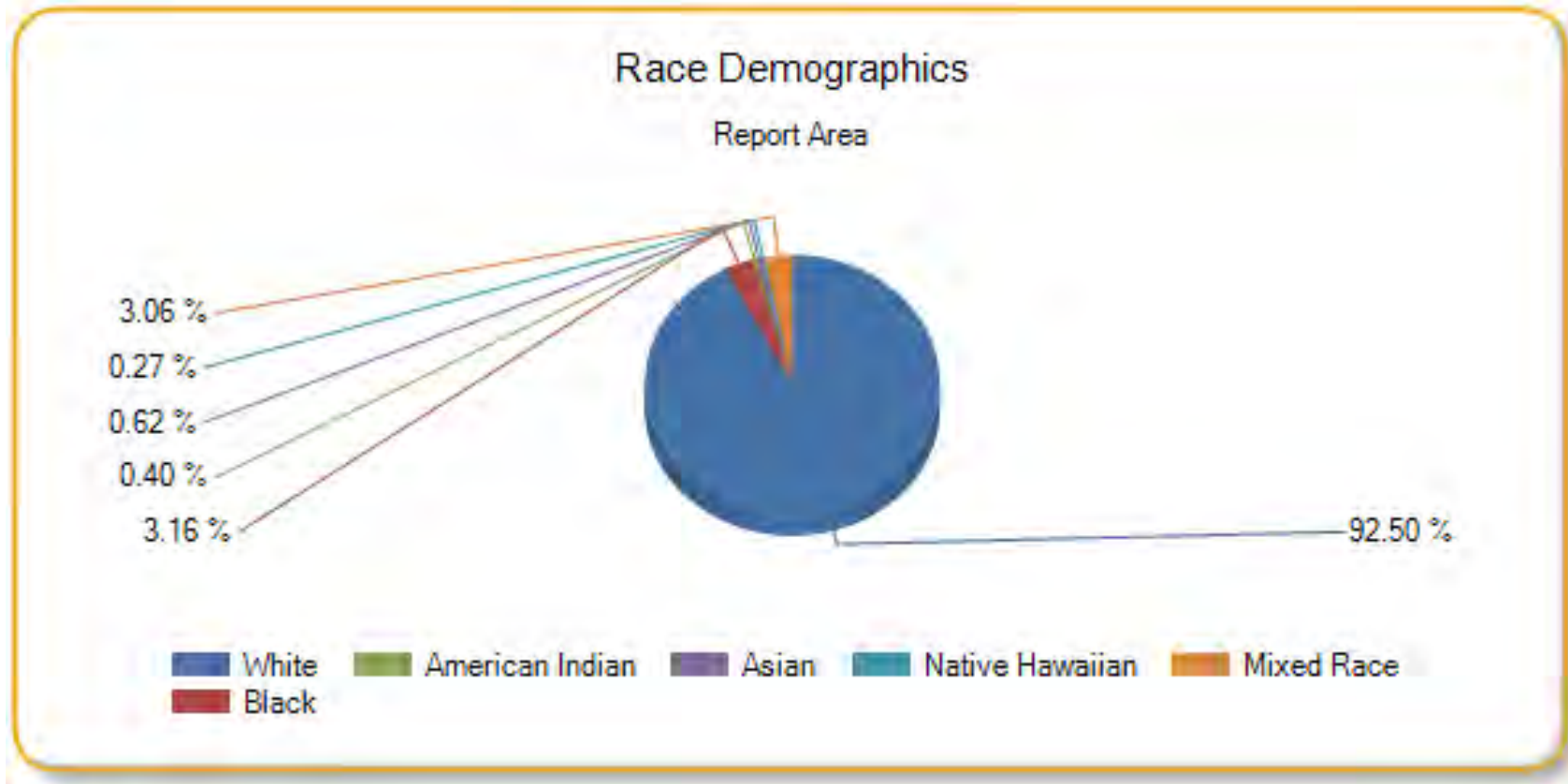

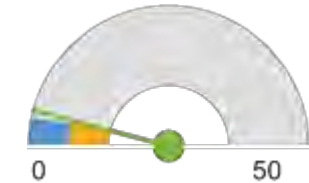

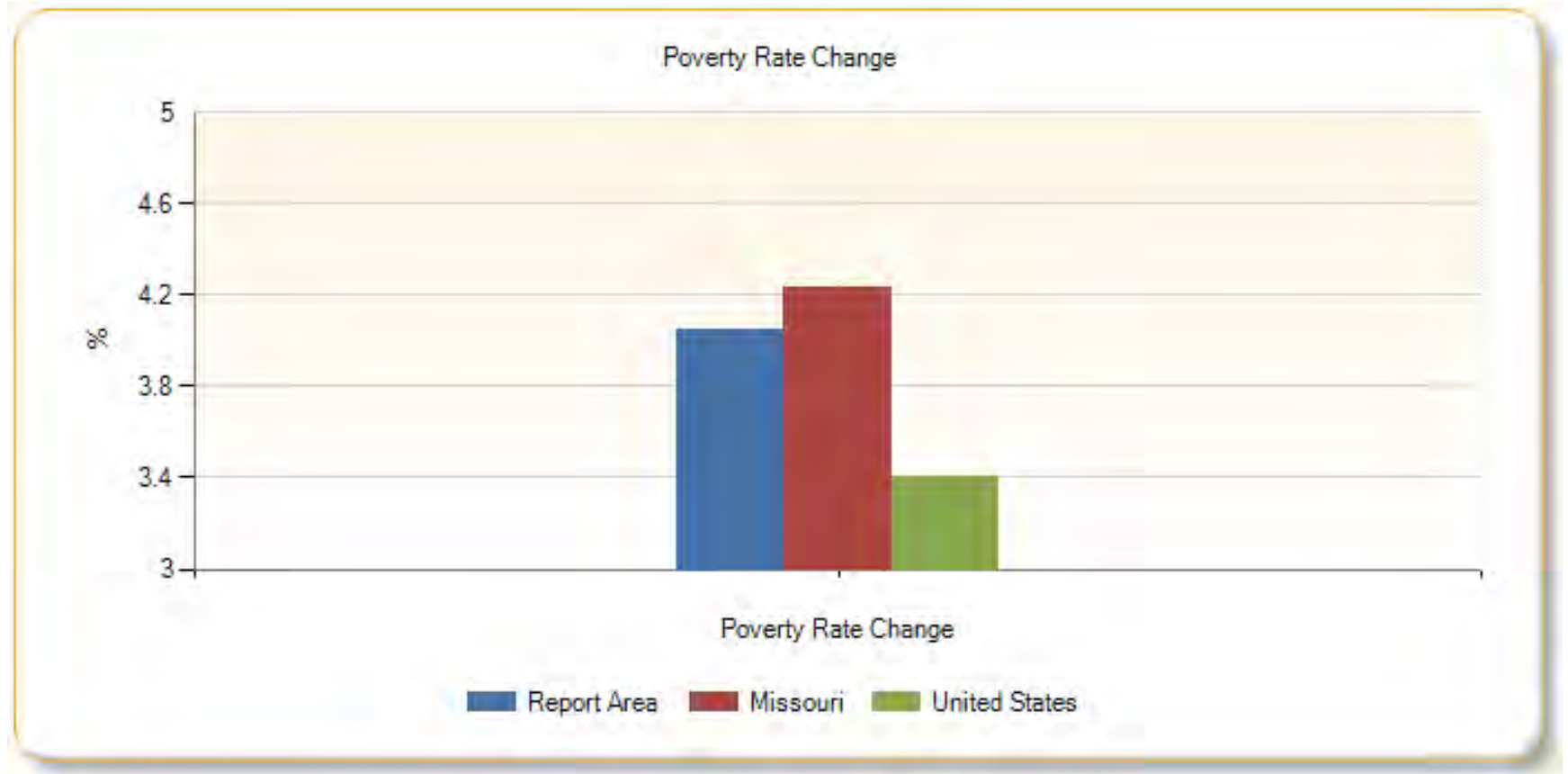
Change in Poverty Rate 2000-2015

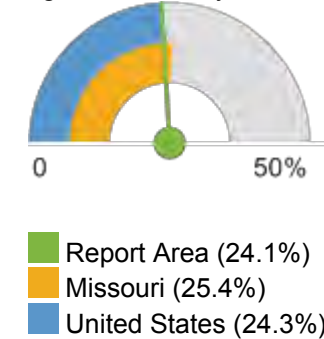

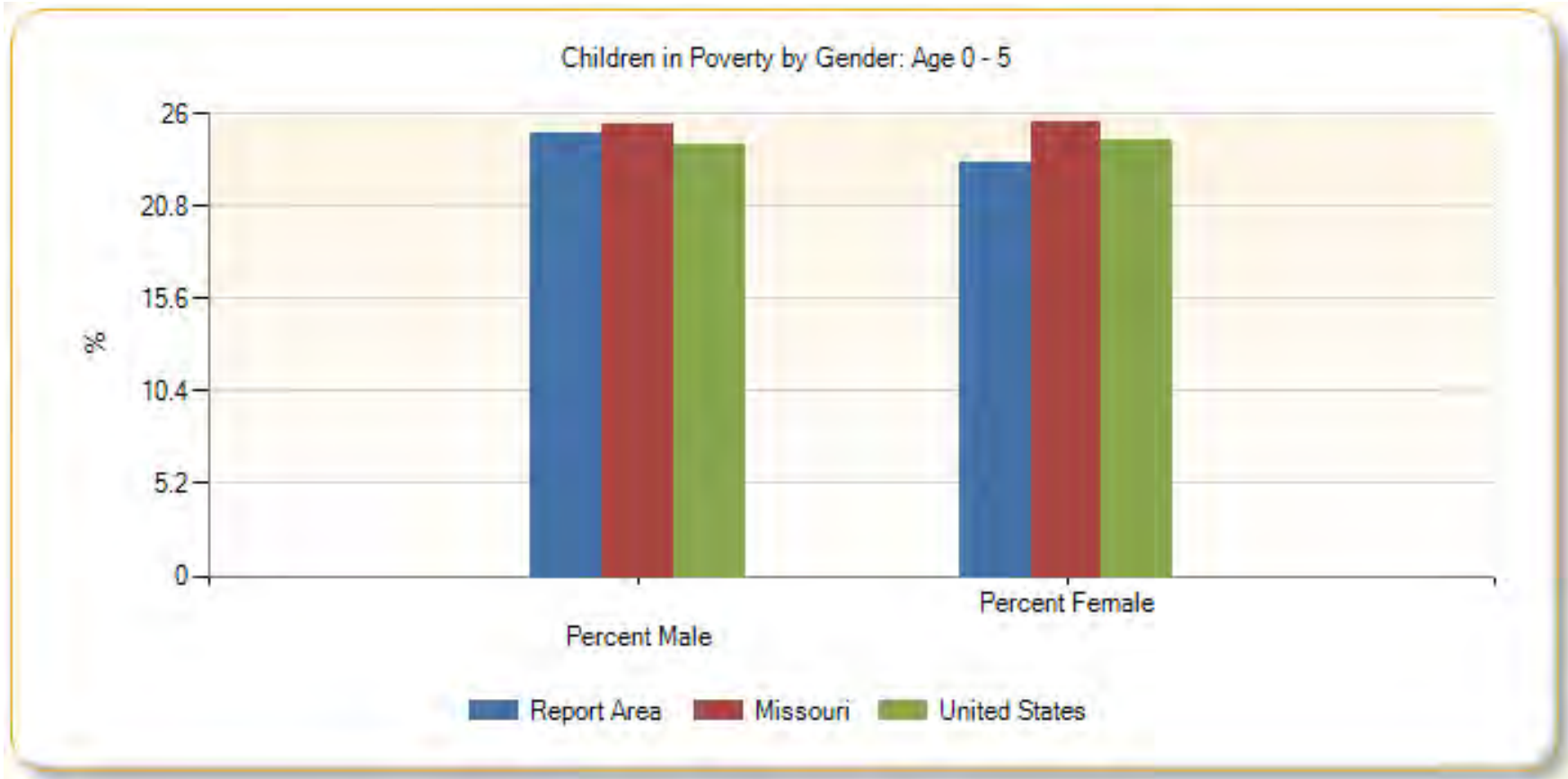
Ages 0-5 Poverty Rate

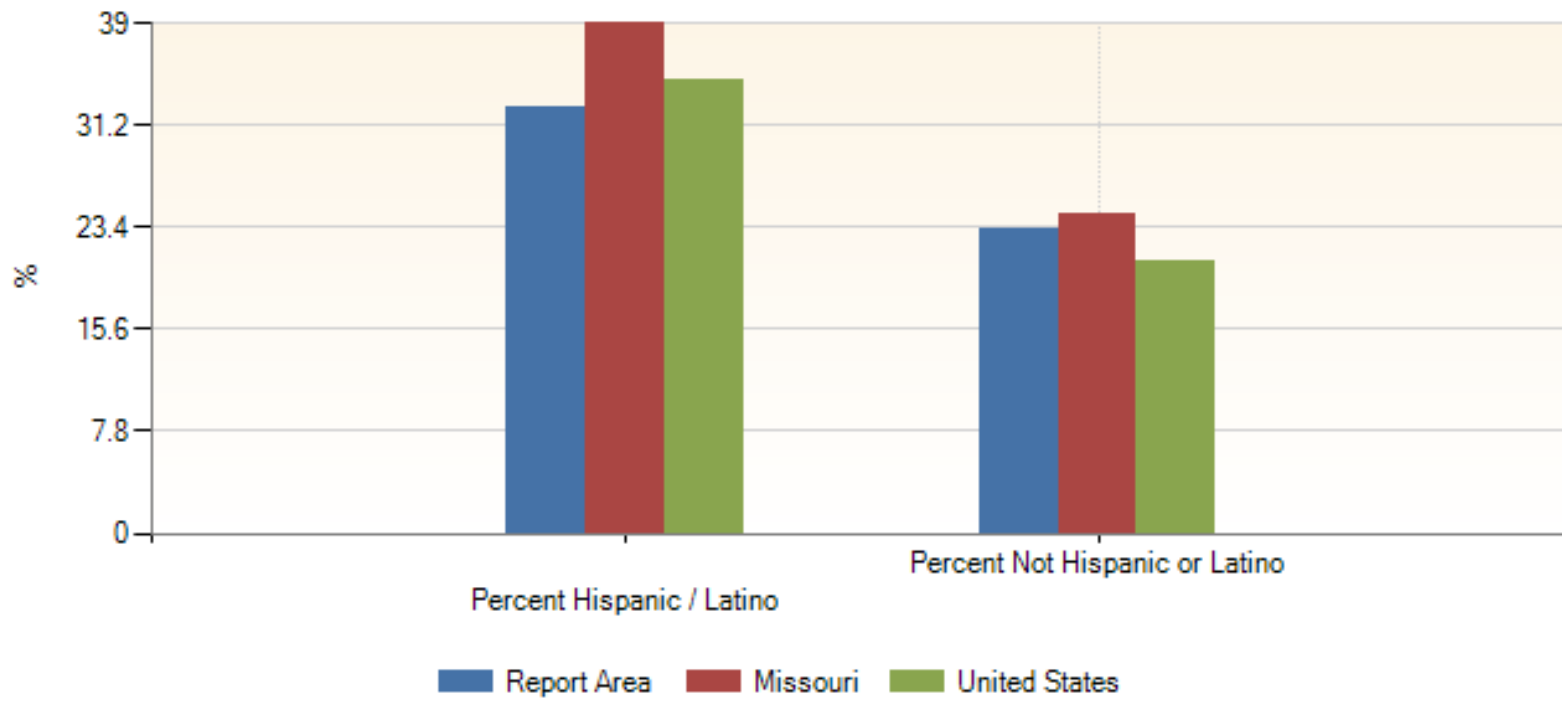

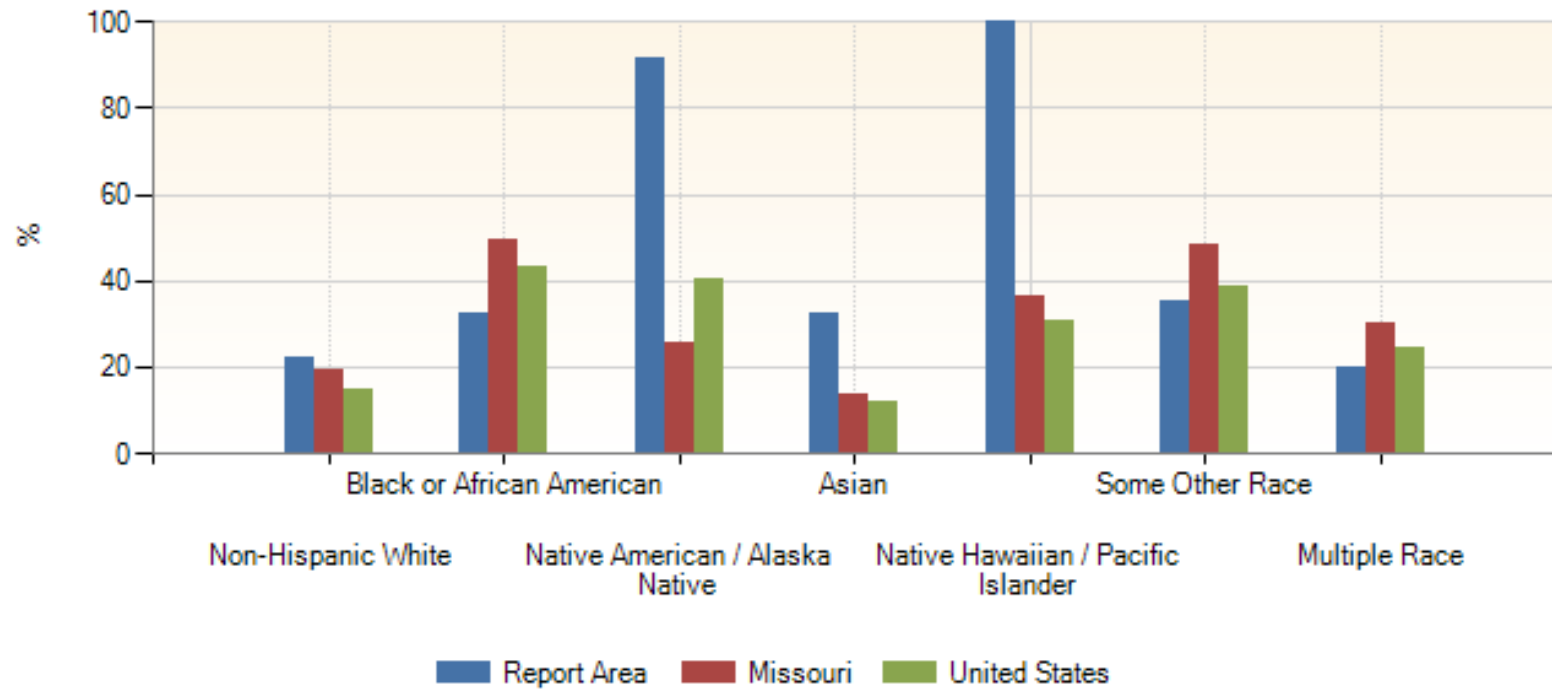

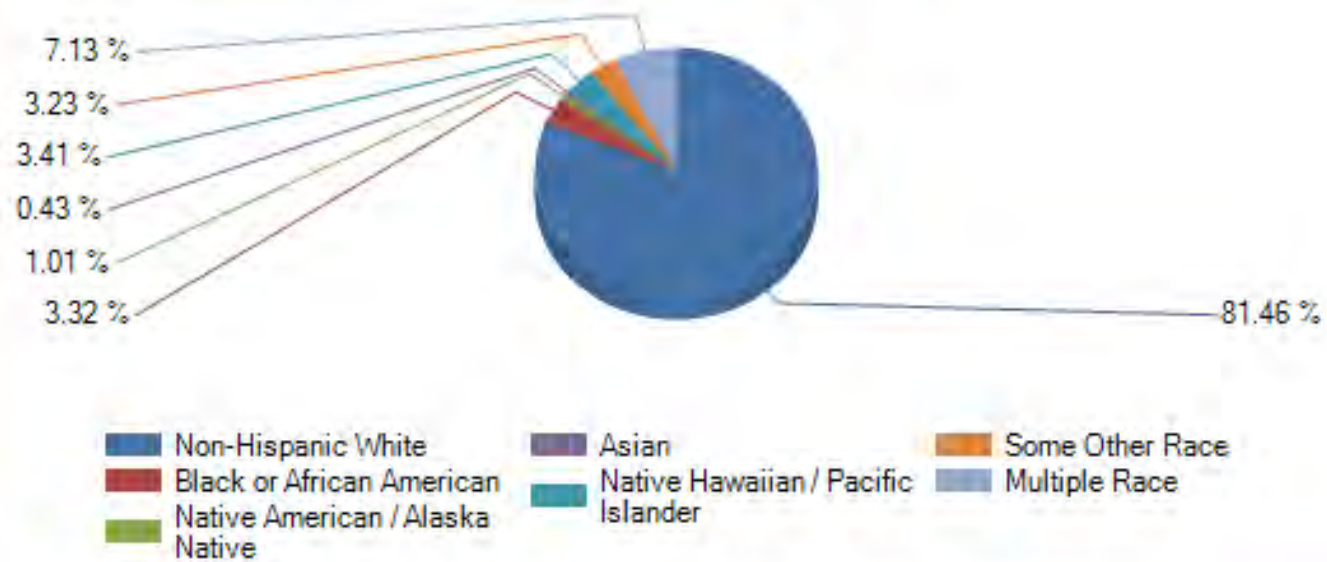

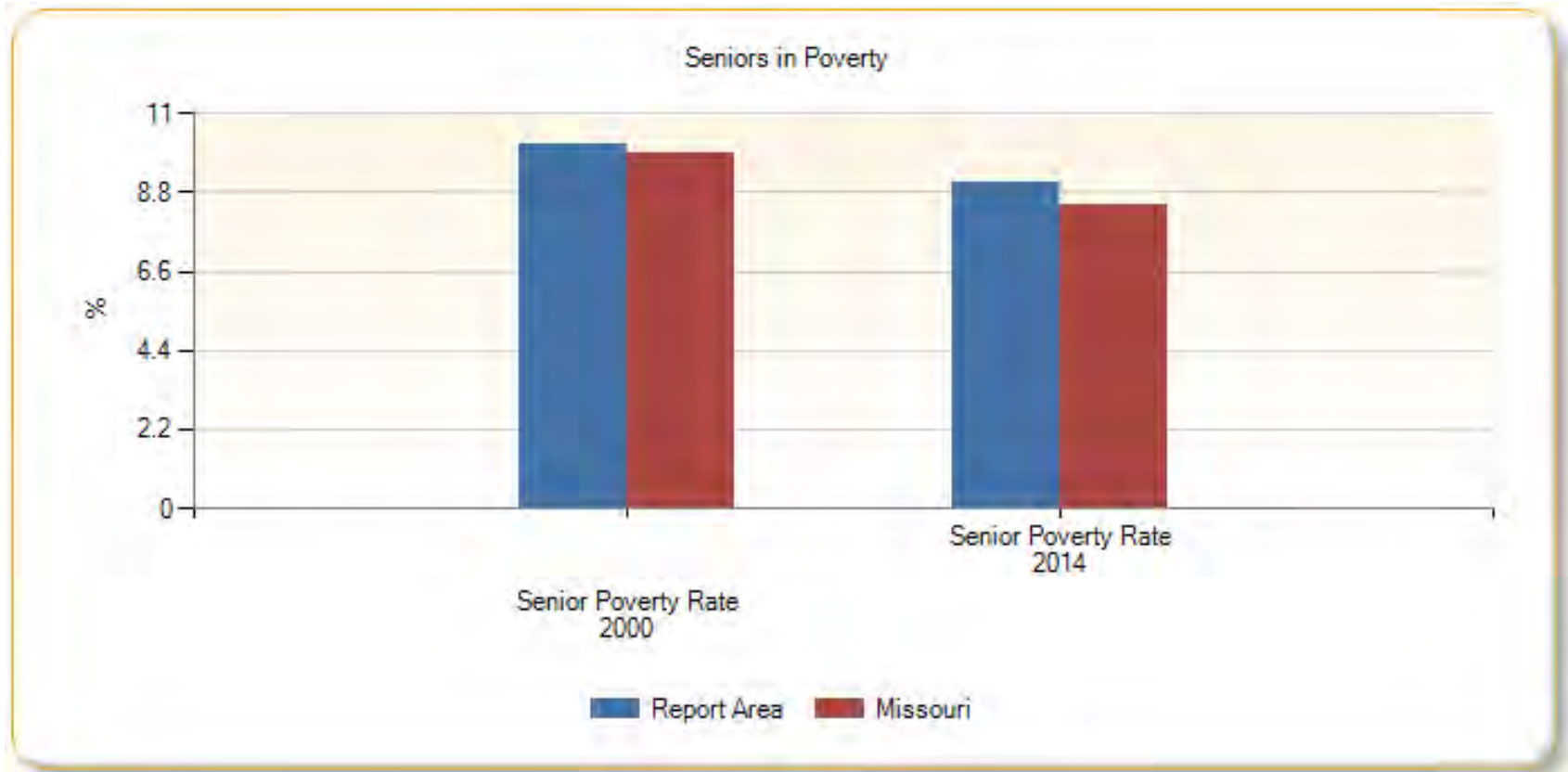

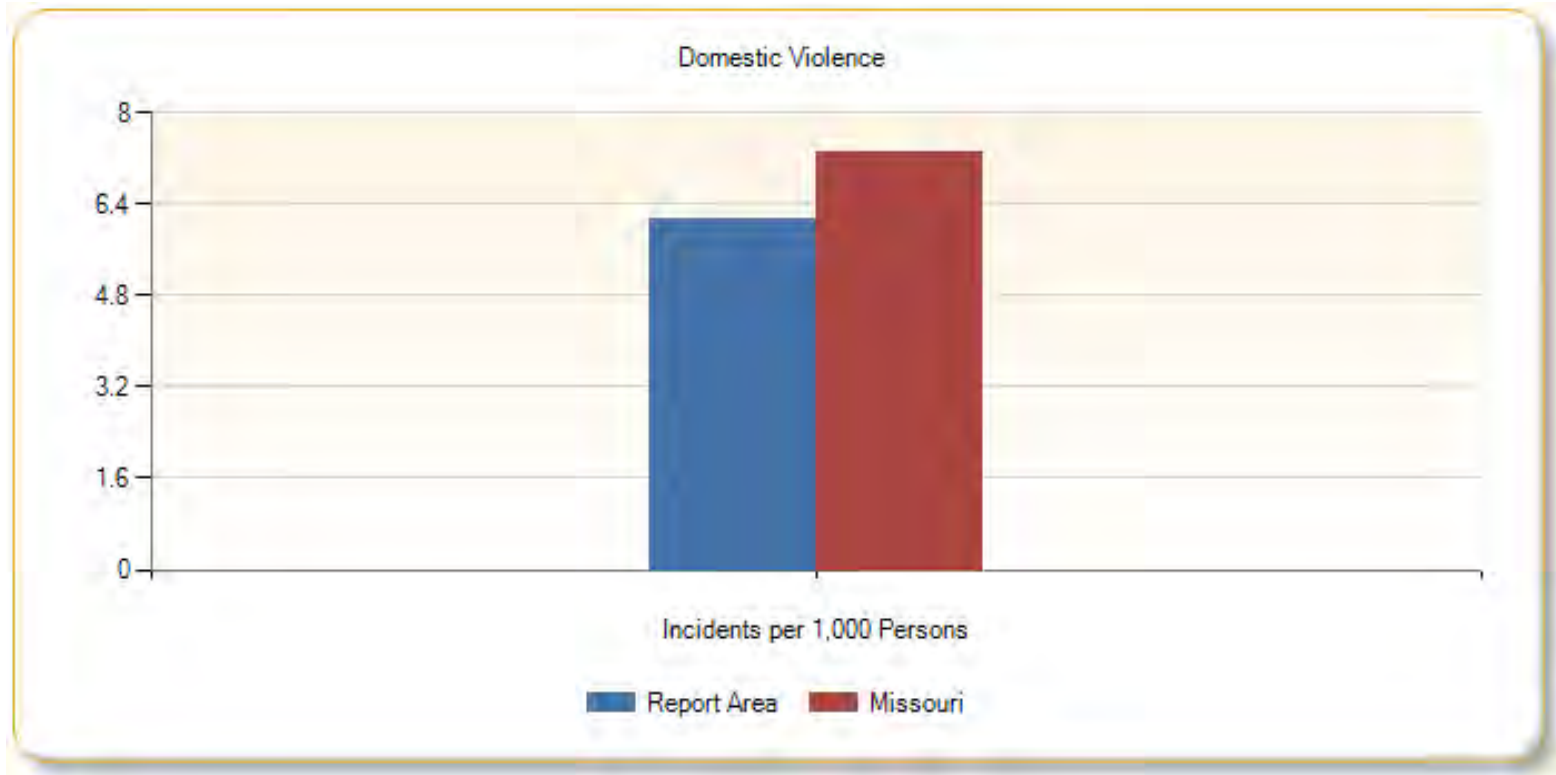

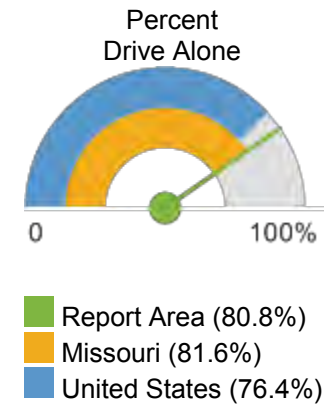

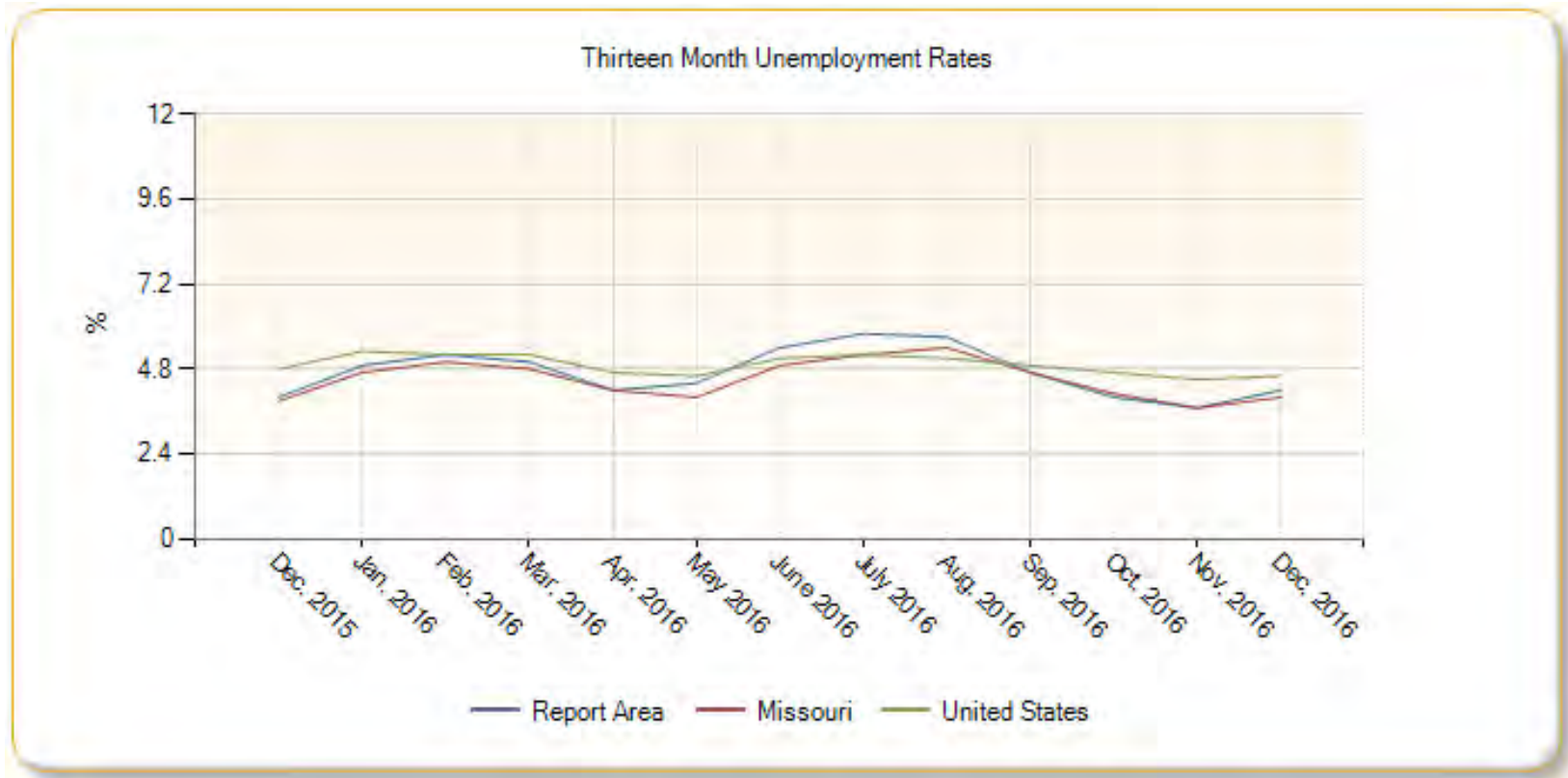

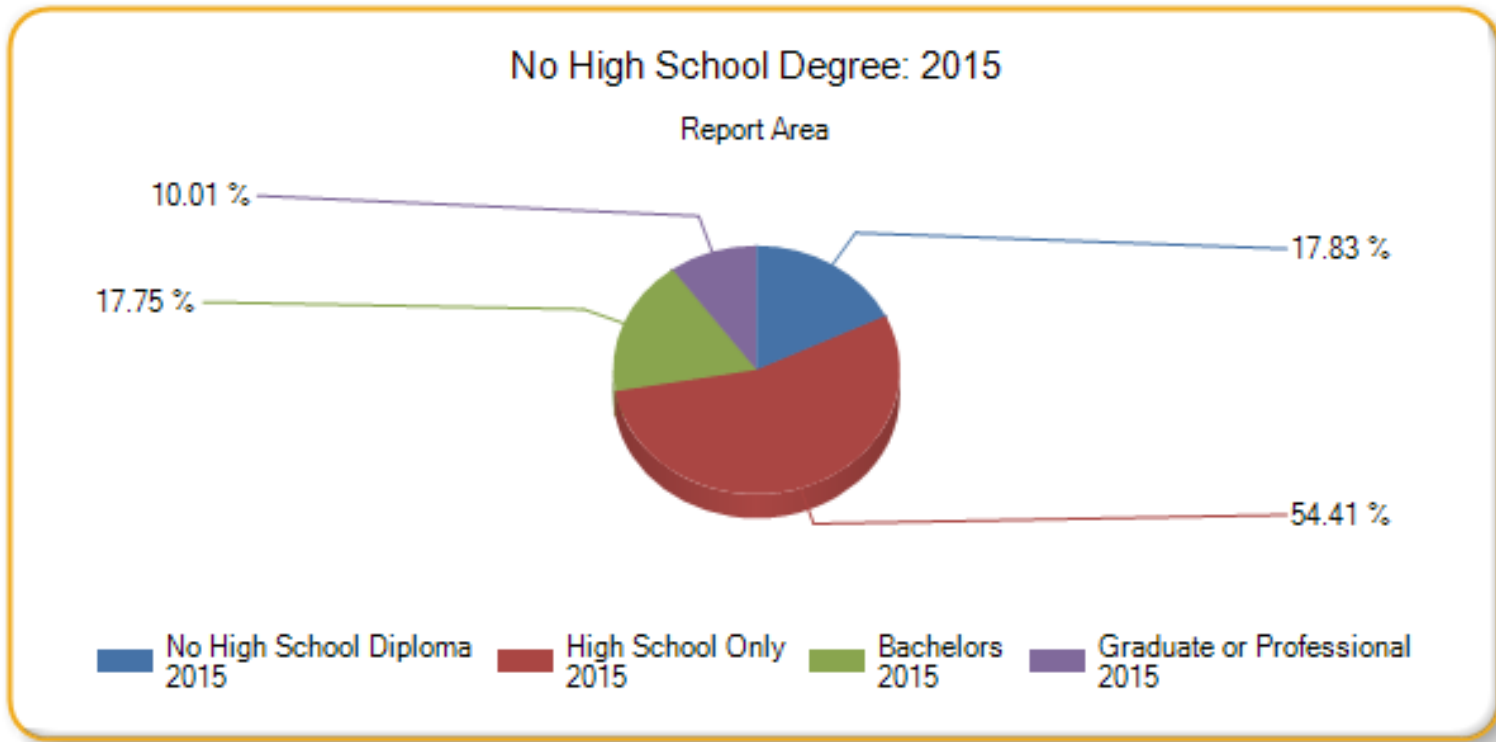

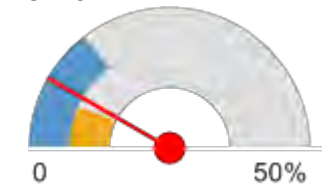

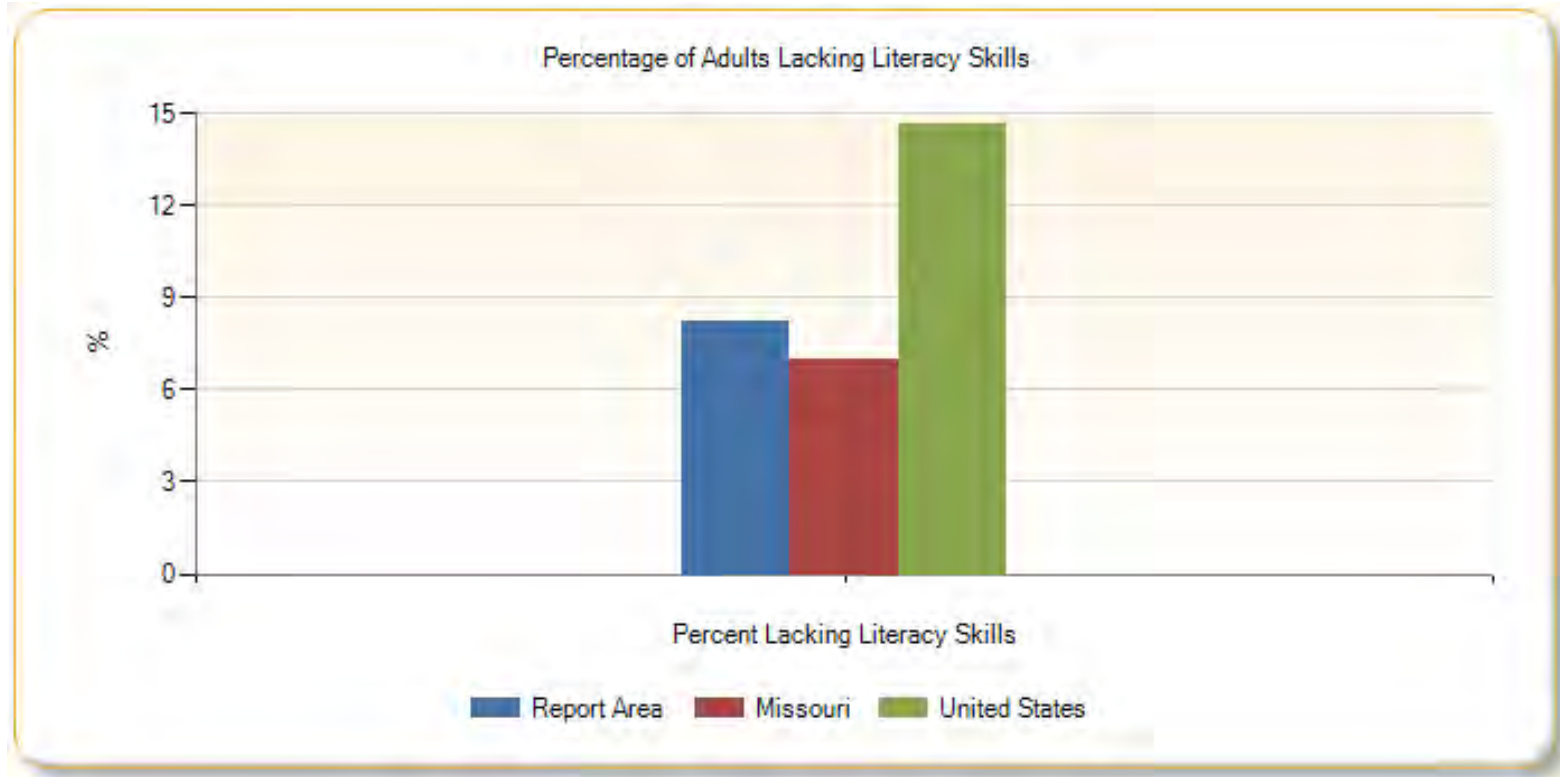

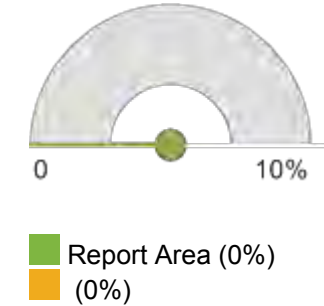

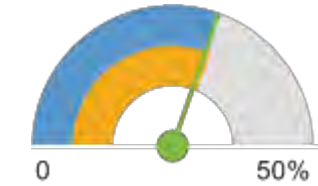

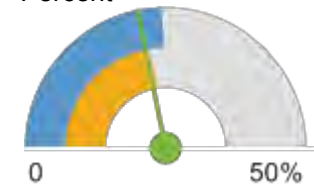

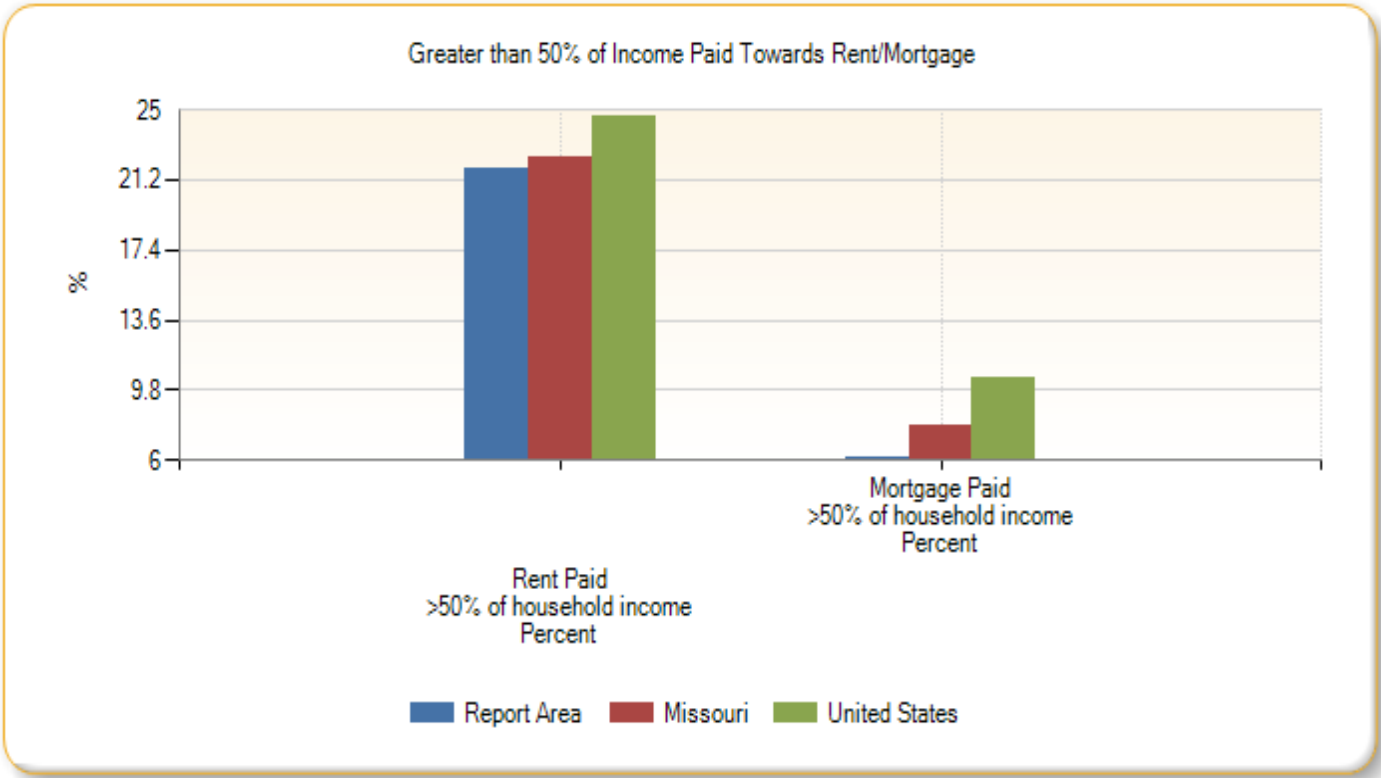

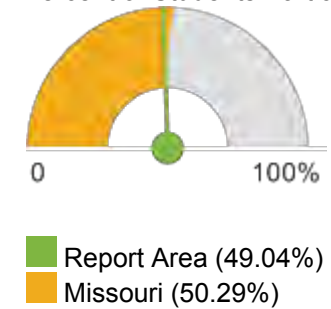

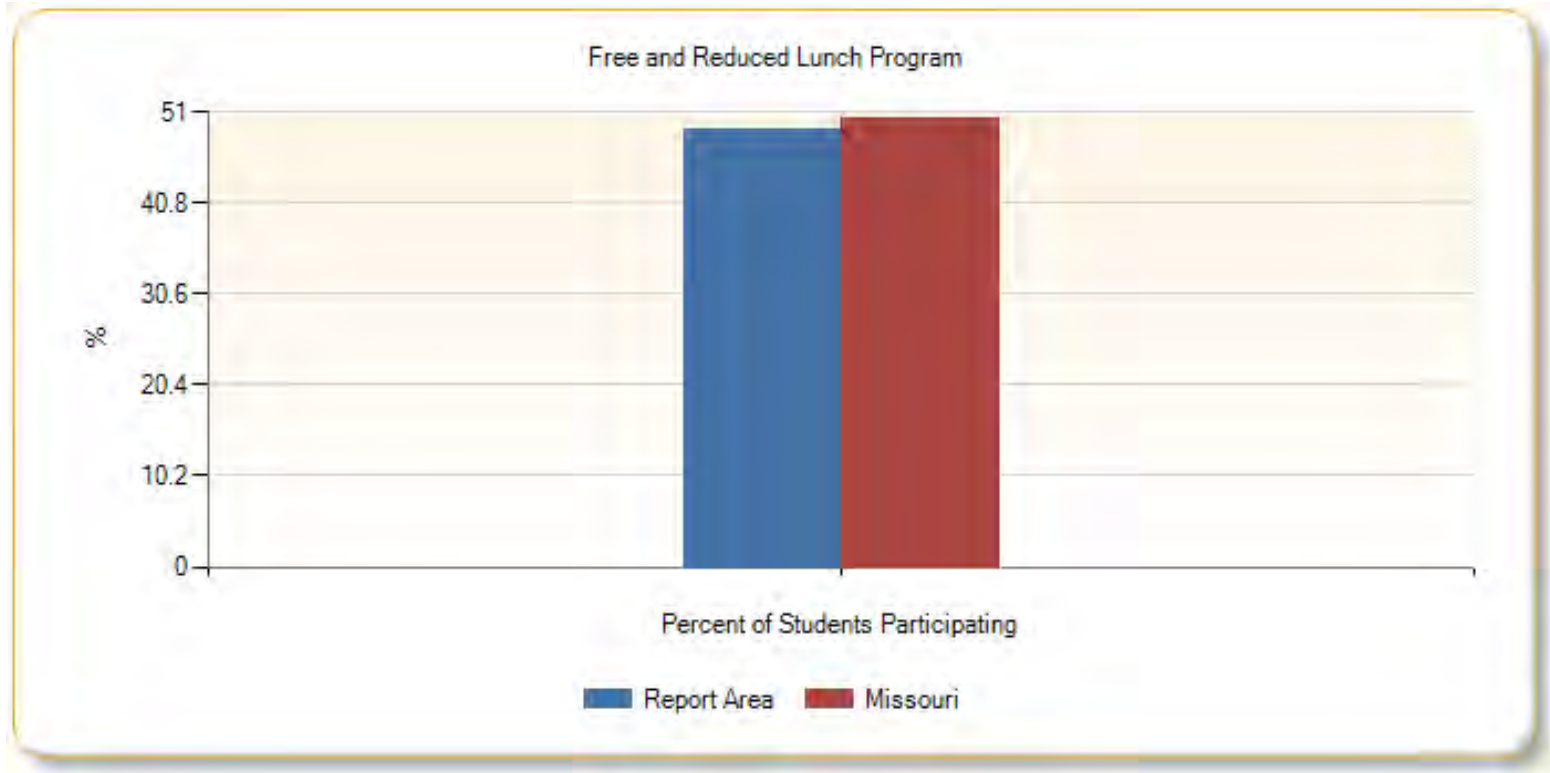

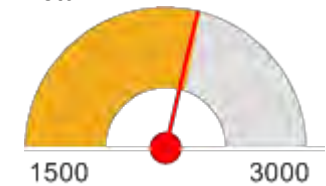

Average EITC Amount per Return



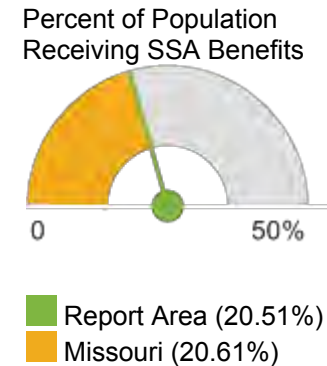

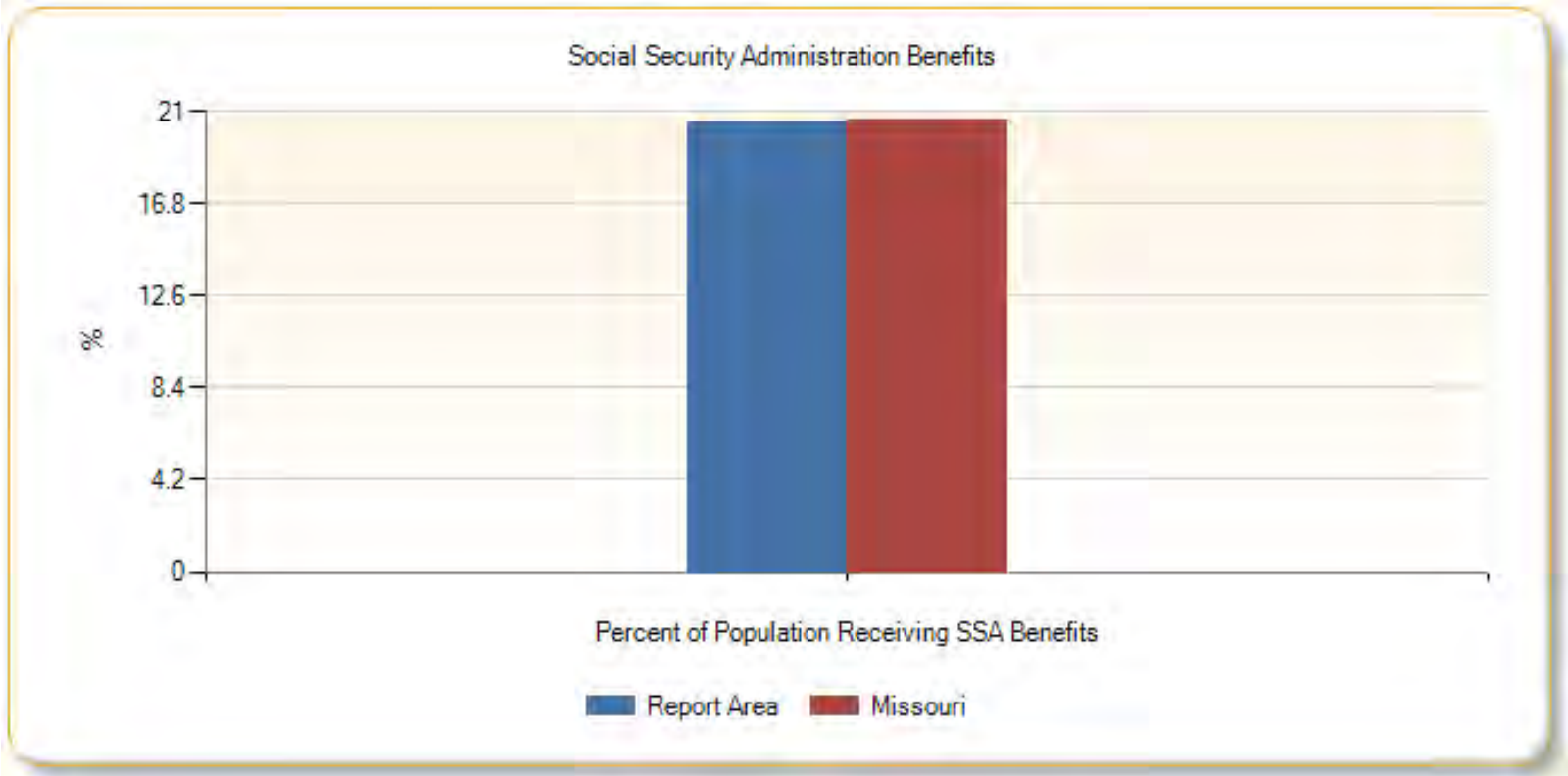

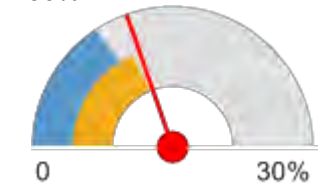

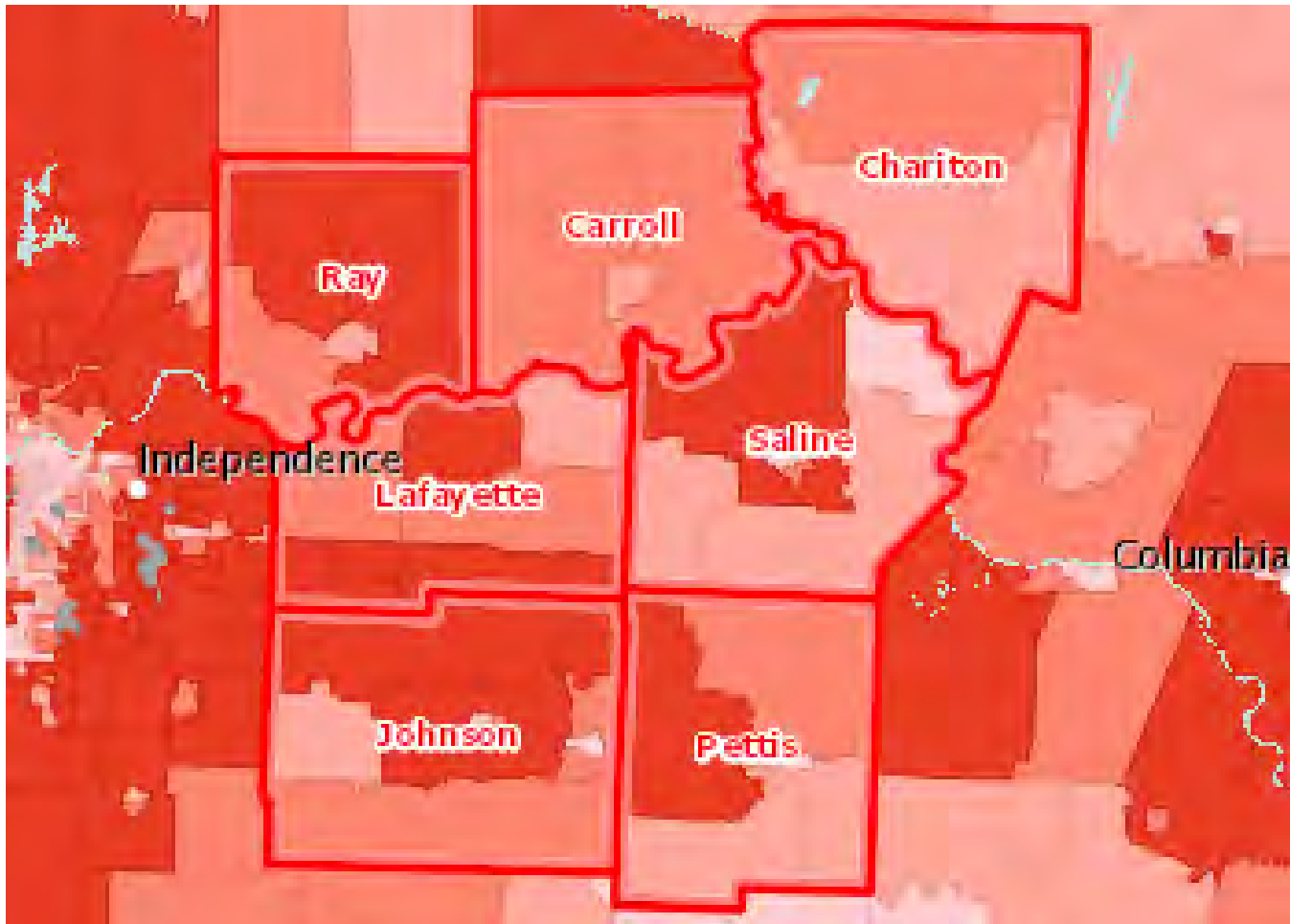

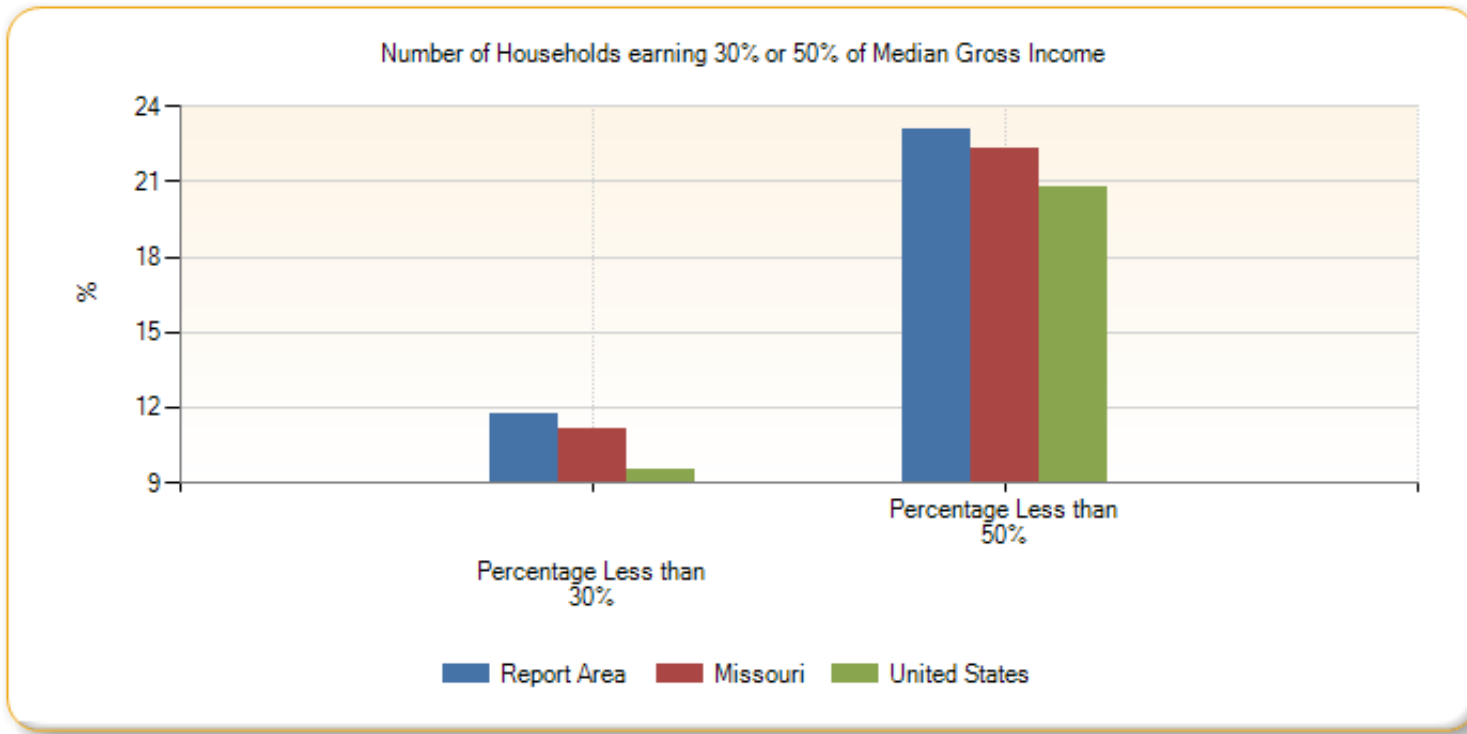

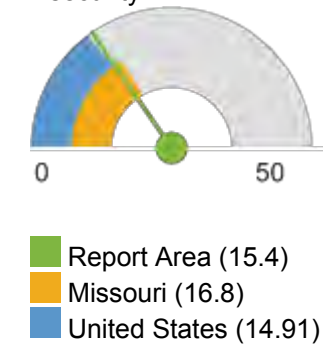

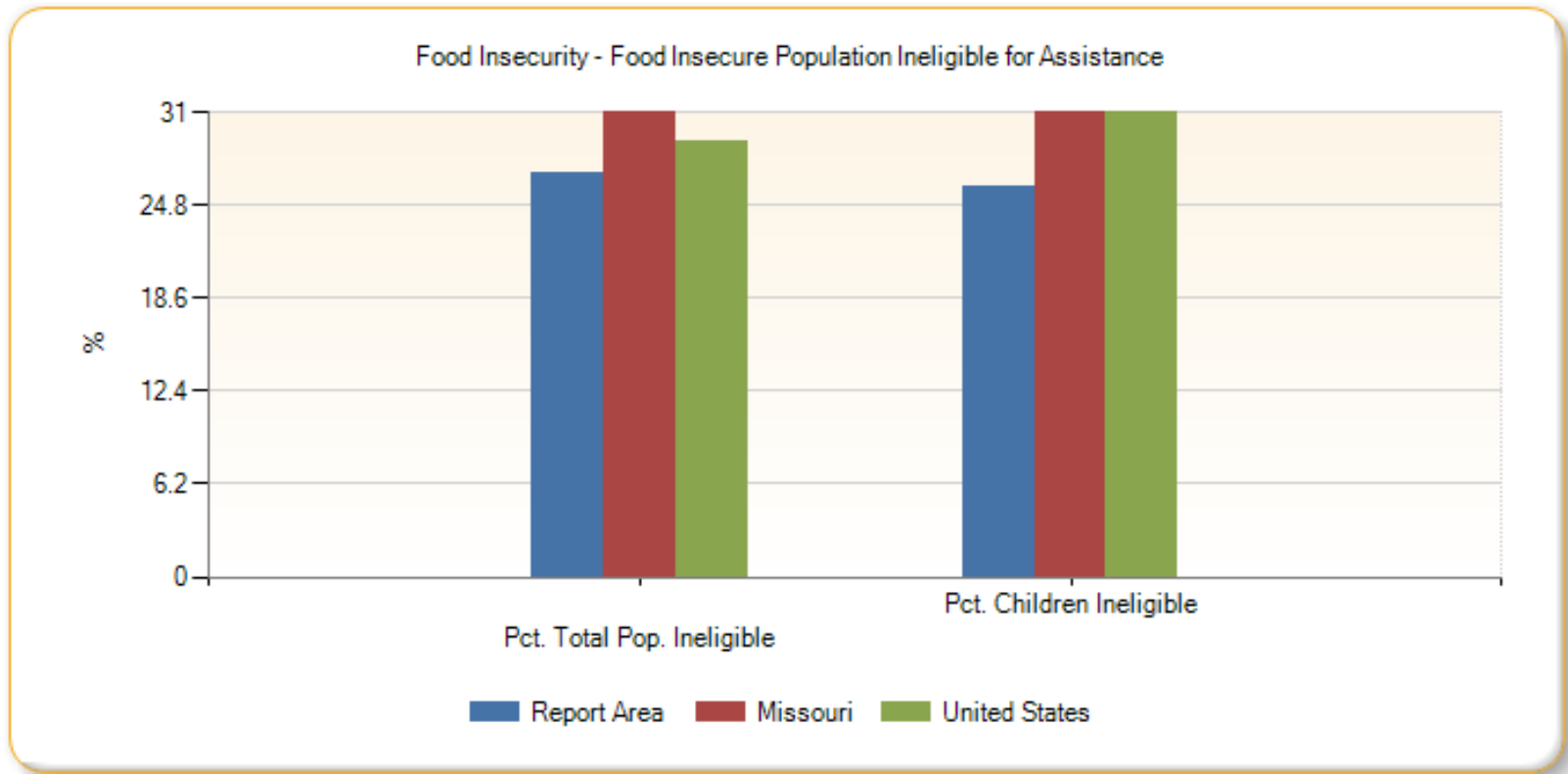

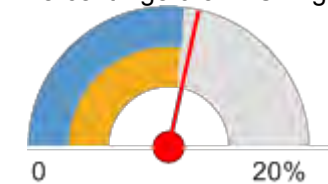

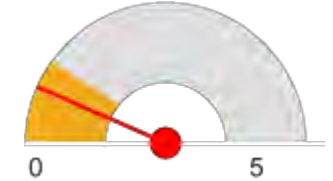

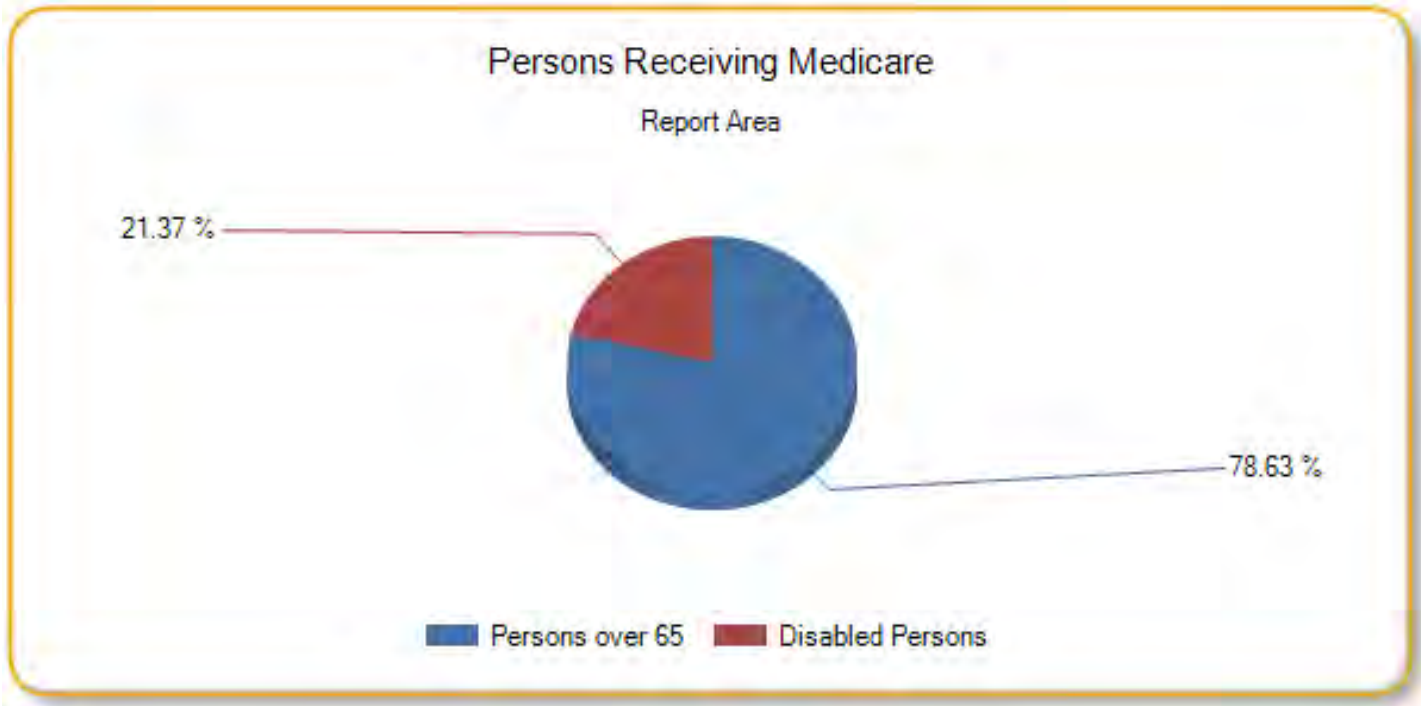

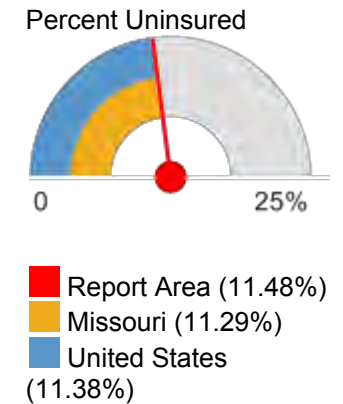

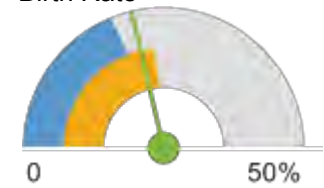

Birth Rate



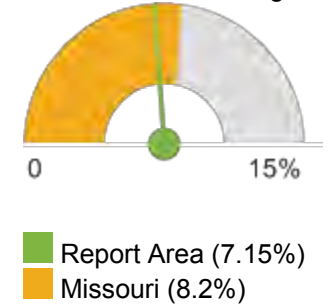

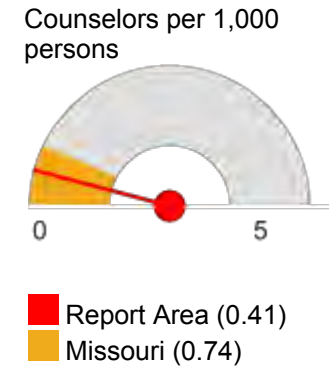
